



## Terms and Conditions

1. airportcharges.com ("*The Product*") is an on-line database of charges ("*Charges*") from several hundred airports across the world maintained and supplied by RDC Aviation of 6 Bridlesmith Chambers, 13-15 Bridlesmith Gate, Nottingham, Nottinghamshire, United Kingdom "*The Licensor*".

2. The Licensor will make airportcharges available by way of an agreement involving a 12-month minimum subscription period. Subscription periods are 12 months from the first of the month following the assignment of a user name and password.

3. Subscription will renew automatically at the end of the 12 month period unless cancelled in writing by The Client at least 30 days before the end of the 12-month subscription period.

4. The Licensor may terminate the agreement at any time and without reason by giving The Client immediate notice. However such action on behalf of The Licensor will not be taken unreasonably.

5. The Licensor will initially limit the number of charges which are downloaded from the site in any individual subscription period to fifty (50) from the start of the subscription period. This will be extended by The Licensor on request from The Client, subject to our fair usage policy, which is available by request.

6. The agreement will be with an individual "*The Client*" within each respective organisation who will be responsible for payment of annual subscription fees and adherence to the terms and conditions of the agreement by all internal users of the service including The Client.

7. Physical access to airportcharges.com is by way of a username and password which are assigned to each individual user either by way of a single or multi-user agreement with The Client at the beginning of the subscription period.

8. The Client may use airportcharges.com for their own private or business research, and for this purpose may:

- display the Charges on screen;
- make printouts of items included in The Product using the printing commands contained in The Product; and
- download and store in machine readable format a single copy of insubstantial portions of the Charges primarily for one person's exclusive use.

9. No other user within The Client's organisation other than the user(s) assigned may access The Product.

10. No part of any information on The Product or downloaded from The Product may be reproduced, recast, reformatted or transmitted in any form by any means, electronic or mechanical, including photocopying, recording or any information storage and retrieval system, without the prior written permission of The Licensor.

11. The Client may not:

- make multiple printouts or copies of Charges or downloaded information for distribution to Unauthorised Persons;
- re-sell the Charges or any part of the Service to others;

- make The Product or any Charges available to Unauthorised Persons on a local area network, a wide area network or on any intranet or extranet;
- decompile, disassemble or reverse engineer any of the software programmes, databases or other systems used by RDC Aviation to provide the service.

12. Ordering access to The Product by way of e-mail, telephone call or any other medium and accessing The Product either in person or through any assigned user is taken as full and unreserved acceptance of all terms and conditions set out herein.
